General Dynamics Land Systems will scan all label data lines to verify readability and correctness. Suppliers will be notified of their scan validation status. If we are unable to successfully scan all the information on the label, we will contact you for corrections.

FAILURE TO COMPLY:

All **Supplier Sample Label Compliance Forms** with sample barcodes must be received by **June 18, 2010**. Barcode labels will be reviewed by GDLS and approved no later than July 9, 2010.

1. All Supplier shipments after July 30, 2010 without barcode labels or nonconforming barcode labels will be returned at the Supplier's expense and/or be charged an administrative fee for costs incurred by GDLS.
2. Failure to comply with this requirement will result in an automatic 0% in Compliance on your Supplier Scorecard for June and each month going forward. This **will** affect Supplier Overall Score and jeopardize Suppliers ability to receive future contract awards.

*** Please note that this requirement to supply a sample barcode label applies to ALL Suppliers; even if previous approval has been given.**
